<p>1 The Buyers and Sellers of digital display advertising shall ensure that the transaction is one pursuant to either (a) a Primary Agreement or (b) the specific terms and policies within an agreed or signed contract.</p>	<p>Viant UK enters into contracts with all users of its technology platform (both buyers and sellers).</p> <p>Buyers that use Viant UK Insertion Orders (IOs), agree to their Advertiser terms and conditions which is accessed via a link on their IO. http://viantinc.co.uk/advertiser-terms-and-conditions/</p> <p>The Viant UK IO also has a link to their Brand Safety Policy.</p> <p>The exception to the above is those buyers who use their own IOs which reference the individual buyer's Terms and Conditions governing their digital display advertising transactions.</p> <p>Sellers sign and agree to Viant UK's Publisher Agreement. http://viantinc.co.uk/publisher-terms-and-conditions/</p> <p>Viant UK also have signed agreements with Real Time Bidding (RTB) exchanges, SSPs and DSPs.</p>
<p>2 A Primary Agreement, or the specific terms and policies within an agreed or signed contract, should include the Buyers and Sellers' intention as to where the advertising should (or should not) appear.</p>	<p>Buyers' Insertion Orders contain intentions to where an ad should or should not appear.</p> <p>Viant UK buyers can select sites from their vetted whitelist (appropriate schedule) to run against their campaigns.</p> <p>Viant UK have a global blacklist (inappropriate schedule), which is run on all campaigns and will also apply blacklists supplied by clients when requested.</p>

<p>The Buyers and Sellers should select from one or both of the following means to minimise ad misplacement:</p> <p>A. Independently-certified (to JICWEBS standards) Content Verification (CV) tool (criteria agreed between the Buyer and Seller pre-delivery); or</p> <p>B. Appropriate / Inappropriate Schedules (criteria agreed between the Buyer and Seller pre-delivery).</p>	
<p>3 Sellers should confirm the specific provisions applied to minimise the risk of ad misplacement, irrespective of whether inventory is sourced directly or indirectly. In the absence of specific provisions, then as a minimum, a statement of reasonable endeavours is required.</p>	<p>Viant UK's Brand Safety Policy States:</p> <p>"Viant UK Ltd. ("Viant UK") will make commercially reasonable endeavours to minimise the risk of ad misplacement in line with the DTSG Good Practice Principles."</p> <p>The Brand Safety Policy also explains the specific provisions used to minimise the risk of ad misplacement.</p> <p>A link to the Brand Safety Policy is contained within Viant UK's Insertion Orders and on all Viant UK's email signatures. http://viantinc.co.uk/brand-safety/</p>
<p>4 Sellers should be able to explain the process(es) that form the basis of specific provisions and/or the reasonable endeavours.</p>	<p>Viant UK use a combination of Appropriate and Inappropriate schedules within their platform.</p> <p>The Viant UK Brand Safety Policy states:</p> <p>"Viant UK's Media Buying team manually vet all sites before being added as a Publisher. Any site deemed to have inappropriate content is barred from the Viant UK network and are added to our Black List of sites"</p> <p>Sites deemed inappropriate are: Adult, Alcohol, Adware/Malware, Hate Speech, Illegal Downloads / Content, Illegal Drugs, Offensive Language and Violence.</p> <p>The inappropriate schedule is run on all campaigns.</p> <p>The buyer may also specify additional domains they would not like their ad to appear on, which is agreed prior to the delivery of the campaign.</p> <p>Viant UK can also run Integral Ad Science's "Ad Safe Firewall" CV tool (approved to JICWEBS standards) upon request.</p>
<p>5 Both Buyers and Sellers should understand any contractual consequences should they fail to monitor this process and respond appropriately to ad misplacement via take down.</p>	<p>Viant UK's Brand Safety Policy states:</p> <p>"In the event an Advert is placed in violation of our Terms & Conditions, Viant UK will use commercially reasonable efforts to remove the Advert within 48 hours of written notification.</p> <p>Where Viant UK has bespoke Terms and Conditions with a buyer Viant UK will use commercially reasonable efforts to remove the Advert within the given time."</p> <p>The Brand Safety Policy also states:</p> <p>"Any contractual consequences resulting from ad misplacement will be defined by the Terms and Conditions accepted within the IO."</p>

We have reviewed Viant UK's policies and procedures for minimising ad misplacement in accordance with the JICWEBS DTSG Good Practice Principles. Our enquiries were designed to independently confirm that the brand safety policies stated have been implemented and clearly documented where required. Our review did not extend to testing the effectiveness of any processes, procedures or controls for ad misplacement.

In our opinion, at the time of our review, Viant UK had established policies to minimise ad misplacement as described in the JICWEBS DTSG Good Practice Principles.
